- The authorization of created and sent payment letters to IVB via web portal of the General Department of Vietnam Customs absolutely fit with the internal authorization roles in our Company and we are fully responsible for authorization roles of the authorizers.
- Unconditional authorization and irrevocable for IVB to debit our opened accounts at IVB listed as above to pay for our payment letters that send to IVB web portal of the General Department of Vietnam Customs and charge E-tax payment service fee (if any) based on IVB current regulated fee. IVB is released all responsibilities when following exact content shown in payment letter received from General Departments of Vietnam Customs.
- The cancelation of authorization is valid only when we pause to use E-tax payment service with the General Department of Vietnam Customs and IVB also gets the information from the General Department of Vietnam Customs about our service pausing.
- The authorization to debit account for E-tax payment is valid from this registration is confirmed by IVB until:
 - $\circ\,$ IVB get our information of service pause from the General Department of Vietnam Customs; or
 - Our accounts have been closed; or
 - $\circ\,$ We receive IVB's unilateral termination of E-tax payment and/ or termination this authorization; or

- Being responsible for late, overdue tax payment because of insufficient account balance or blocked account or wrong tax payment information.
- Being in charge of co-operating with IVB to make dispute of E-tax payment transaction as request of IVB, State Treasury, Customs Department and completely responsible for submitting information.
- Promptly inform IVB and Customs Department to solve the related issues as following:
 - o Doubt or detect illegal accessing E-tax payment service
 - Doubt revealed password of E-tax payment service
 - Lost security device
- We are responsible for the truth of information and the security of account information loggedin E-Banking service on the web portal of the General Department of Vietnam Customs. IVB is fully released responsibility, including the case customers detect sophistication, impersonation or implementation by person without authority.
- We commit to refund all the loss happened in reality to IVB if do not implement the obligations in this registration.
